**Sub : Calling for applications from fresh as well as repeater candidates intending to appear in Subordinate Audit/Accounts Service (SAS)/RA/CPD-I Examination to be held in August-2015**

In terms of Headquarters Examination circular No 04 of 2015 issued vide No./108/45-Exam/Circulars/August\_15/2010 (Vol.III) dated 31.03.2015, it has been decided by Headquarters office to hold the aforesaid examination in the August 2015.

In view of the above, the applications in the prescribed proforma (enclosed) are invited from eligible fresh as well as repeater candidates intending to appear annual SAS/RA/CPD-I examination to be held in August 2015.

The applicants will have to register their names online like previous year, which will be notified in due course.

**Eligibility criteria for Revenue Audit Examinations**

In terms of revised para 9.3.1.1 of MSO Admn (Vol-I) dated 20.02.2014, Sr. AOs/AOs after having one years of continuous service in the Revenue Audit Branch as AAO/AO/Sr. AO or after having prescribed training in the Revenue audit , (b) Departmental Officials who are promoted as AAO are eligible to appear in Revenue Audit Examination after completion of one year of continuous service in Revenue Audit Branch; or have the prescribed training in Revenue Audit after completion of one year of continuous service as AAO, (c) Confirmed directly Recruited AAOs are eligible to appear in Revenue Audit Examination after completion of one year of regular service in Revenue Audit Branch as a regular AAO; or have the prescribed training in Revenue Audit after completion of one year of regular service after confirmation as AAO.

**Eligibility criteria for CPD-I Examinations**

All Sr.AOs and AOs shall be eligible to take the first CPD test. AAOs including AAOs (Regular Temporary) shall be eligible to appear in the first CPD test after completion of five years' continuous service in the grade on the 1<sup>st</sup> of the month in which the examination is held.

The last date for receipt of applications for fresh candidates in Examination section (G&SSA) is 11.05.2015. The repeater candidates should submit their applications within a week of declaration of result of SAS/RA/CPD-I Exam-Feb-Mar-2015.
