CIRCULAR.

Sub' Calling for applications from eligible candidates to appear at the ensuing Annual SAS (Civil Accounts/Audit) for both Group-I /II / Incentive / CPD-1 & II Examination to be held in September 2018.

The next Annual/Main Subordinate Audit/Accounts Service examination, Incentive Examination for Sr.AO/AO/AAO/Sr.DAO/DAO-Gr-I and Continuous Professional Development-I and CPD-II Test for Sr.AO/AO/AAO/Sr.DAO/DAO-Gr-I is scheduled to be held in the month of September 2018 in terms of Hdqrs Circular No. 02 of 2018 communicated vide Letter No. 188/04-Exam/Progr./Annual SAS/RA/I/CPD-I & II/Sept.18 dated 06.03.2018.

The eligibility criteria to appear in SAS (Audit/Accounts)/Incentive Exam/CPD-I & CPD-II Examination of September 2018 is as below:-

SAS Examination

- SAS (Civil Accounts) for A&E officials: All the eligible candidates (including fresh candidates) from A&E Offices have the option either to write SAS (Civil Accounts) Examination or opt for SAS (Civil audit) Main Examination 2018. However, candidates after getting promotion as Assistant Accounts Officer / Accounts Officer cannot be allowed to appear in SAS (Civil Audit) Examination 2018.
- After passing the SAS (Civil Audit) Examination, the eligible officials from A&E offices shall be eligible for deputation-cum-eventual absorption in deficit Civil Audit Offices only. However, as per provision contained in Recruitment Rules to the post of Assistant Audit Officer, the maximum age limit for appointment by deputation shall not be exceeding fiftysix year as on the closing date of receipt of application.
- The existing A&E officials, who are still appearing in SAS (Audit) Examination for their eventual absorption in Audit offices on attaining the age of 56 years at the time of holding of SAS examination, are not permitted to appear in SAS (Audit) Examination 2018.
- Those officials who have successfully passed the SAS (Accounts) Preliminary Examination conducted during 2018 and completed the mandatory pre-examination training are eligible to appear the said examination subject to condition that they would be completing two years continuous service in one or more capacities and would be successfully completing their probation period as on 01.09.2018. In case of failure to complete the probation period successfully on 01.09.2018, the candidature of such officials should be cancelled.
- Those Divisional Accountant / Divisional Accounts Officer Grade-II who have completed their probation period of 2 years successfully and confirmed in the cadre as on 01.09.2018 are eligible to appear the said examination.
- The candidates who have taken previous SOG Examination and have not taken examination under CBT mode are also eligible to appear SAS Examination to be held in September 2018.
- A&E officials who had appeared previously in Civil Audit Examination but failed therein
 may be allowed to appear in the Civil Accounts branch Examination. However, all their
 previous chances which they have exhausted while appearing in the SAS (Civil Audit)
 examination may be taken into account while reckoning their remaining number of chances.
 Further, they may not be allowed to appear in the Civil Audit examination till the time SAS
 Civil Accounts Examination is open in their parent offices.

- A & E employees who have passed the Civil Audit branch and are presently on deputation in Audit offices for their eventual absorption in Audit Offices are not allowed to appear in the SAS (Civil Accounts) Examination.
- SAS Civil Audit passed candidates of A&E offices, who could not be absorbed in Audit Stream, shall have to clear the remaining papers of SAS (Civil Accounts) Examination for their promotion as Assistant Accounts Officer. However, such officials would be allowed to appear in the SAS (Civil Accounts) Examination only after furnishing a written undertaking that they agree to forfeit their claim for deputation-cum-eventual absorption in any Civil Audit Office. Further, all their previous chances, which they have exhausted while appearing in the SAS (Civil Audit) examination, would be taken into account while reckoning their remaining number of chances.
- Those Candidates who have exhausted all the six chances and secured exemption in / passed five papers of SAS Examination have been given (4) more consecutive chances commencing from the immediately successive examination and lapsing immediately after conclusion of 4 consecutive SAS examination. Withdrawal of candidature is NOT permissible once the candidate is registered.

• Junior Translator & Senior Translator of Rajbhasha cadre who have already passed few papers of SAS Exams.

i) The official who has already passed one or more papers(s) shall be allowed to appear in the same stream from the new office.

ii) Option to choose a different stream of SAS examination shall be as per laid down procedure for the same, but within the stipulated number of chances permitted under the rule in vogue (including those attempts already made).

iii) Common papers cleared in existing stream and new stream opted shall be treated as

exempted from passing those common papers.

iv) After passing the SAS examination, the official shall be allowed to be promoted in the previous office from where the official has passed SAS Preliminary Examination.

v) The seniority of the official who has already passed one or more paper(s) and appears in the same stream from the new office, the seniority after passing SAS Examination in AAO cadre in previous office shall be regulated as per existing practice.

vi) In case the official chooses a different office in the same stream then the official has to apply on deputation cum absorption basis, as per the existing policy as applicable in case of SAS (Civil Accounts) passed officials of A&E office on passing the SAS

(Civil Audit) Examination.

vii) The official who has chosen a different stream of SAS Examination as per laid down procedure, on passing the SAS Examination, the official shall be considered for app ointment in AAO cadre in an office in the chosen sream. The official has to apply on deputation cum absorption basis, as per existing policy as applicable in case of SAS (Civil Accounts) passed official of A&E office on pass the SAS (Civil Audit) Examination.

viii) The seniority of official mentioned in Sl. No. vi & vii above, who apply for appointment on deputation cum absorption basis as AAO shall be fixed below the

promoted eligible departmental candidates (AAOs).

Junior Translator & Senior Translator of Rajbhasha cadre who will appear SAS
examination on a future date.

i) Such Rajbhasha cadre official shall be permitted to choose any stream of SAS i.e. Civil Accounts, Civil Audit, Railway Audit, Defense Audit, Commercial Audit and Post and Telecommunication Audit even though the official is not presently posted in the offices of the stream he/she opted.

- ii) On passing the SAS Examination, the official shall be considered for appointment in AAO cadre in an office in the chosen stream. The official shall apply on deputation cum absorption basis, as per existing policy as applicable in case of SAS (Civil Accounts) passed official of A&E office on passing the SAS (Civil Audit) Examination.
- iii) The seniority of official mentioned at Sl. No i & ii above, who apply for appointment on deputation cum absorption basis as AAO shall be fixed below the promoted eligible departmental candidates (AAOs).

Incentive Examination

The following officers are eligible to appear the Incentive Examination September 2018

- 1. Those Assistant Accounts Officers / Assistant Accounts Officer (RT) in A&E offices, who have put in one year continuous service in the grade as on 01.09.2018.
- 2. Those Divisional Accounts officers Grade-I (DAO- Grade-I) who have put in one year continuous service in the grade as on 01.09.2018.
- 3. All Sr. Accounts Officer's / Accounts Officers / Senior Divisional Accounts Officer (Sr. DAO).

CPD -I Test

The following officers are eligible to appear the CPD-I Examination September 2018.

- 1. All Sr. AOs and AOs are eligible to take the first CPD test.
- 2. All AAOs including AAO (RT) would be eligible to appear in the first CPD test after completion of four years; continuous service in the grade as on the 1st of September 2018.
- 3. All Senior Divisional Accounts Officers in Pay Band-3 (Rs 15600-39100) with Grade Pay of ₹ 5400 are eligible to appear in the first CPD-I Examination.
- 4. Divisional Accounts Officer Grade-I in the Pay Band-2 (9300-34800) with Grade Pay of ₹ 4800 are eligible to appear in the first CPD-I test after completion of four years of continuous service in the grade as on 1st of September 2018.

CPD-II Test

The following officers are eligible to appear the CPD-II Examination September 2018.

All successful candidates of CDP-I Examination, who have passed the CPD-I (Main) Examination held in August 2014.

In view of the above, all eligible officers / officials of the Office of the Principal Accountant General (A&E), Odisha, Bhubaneswar including Branch Office at Puri intending to appear at the above examinations in September 2018 may submit their application, duly filled in, in the prescribed proforma available in Admn.I section latest by 17.08.2018. Applications received after due date or in incomplete shape will be rejected.

However, candidates who come out successful in the ensuring Preliminary Test for appearing the SAS (Civil Accounts) Main Examination 2018 scheduled to be held on 24.07.2018 may apply for fresh registration within 1 week from the date of declaration of Preliminary Test for SAS (Civil Accounts) Main Examination 2018 results or 17.08.2018 whichever is later.
