Sub: Grant of grade pay of Rs. 5400/-(PB-2) i.e Level-9 of Pay Matrix to Divisional Accounts Officer Grade-I (DAO-1) on completion of 04 years of service in grade pay of Rs. 4800/-(Level-8 of Pay Matrix) in IA & AD-regarding.

In accordance with Hdqrs Circular vide No.21-Staff Wing/2019 communicated vide No.571-Staff (Appt.)/PC Cell/02-2017 dated. 14.05.2019 the pay of DAOs-I in IA & AD under revised pay structure of 7th CPC w.e.f. 01.01.2016 would be in Level-8 of pay Matrix and in Level-9, on completion of 04 years in Grade Pay of Rs.4,800/-(PB-2)/Level-8, subject to the following terms and conditions:

- i. The grant of Non-functional upgradation (NFU) in Pay Level-9 shall be admissible to the DAOs-I of IA & AD on completion of 04 years of regular service in the cadre from the date of joining as DAO-I. The aforesaid non-functional upgradation (NFU) to DAOs-I is effective from **01.01.2016**.
- ii. The benefit of pay fixation admissible as per Rule 13 of CCS (RP) Rules, 2016 shall be available at the time of grant of non-functional upgradation.
- iii. NFU will be reckoned for financial upgradation under Modified Assured Career Progression Scheme (MACPS), if any, is to be reckoned from the date of grant of NFU.

In view of the above, officers/officials as listed in Annexure-I enclosed herewith are required to submit their Service Books with up-dated entries to this office.. They shall also exercise their option for fixation of pay under FR 22(I)(a)(i) within a period of one month from the date of issue of this order as per OM No.13/02/2017-Estt.(Pay-I) dated 27.07.2017 of Department of Personnel & Training, Public Grievances and Pensions, Ministry of Personnel, Government of India to this office immediately for consideration of grant of NFU.
