Sub Online Registration for SAS/RA/I/CPD I & II Supplementary Examination of Main Examination 2019.

Hdqrs office in Circular No:7 of 2020 issued vide No. 159/09-Exam / Annual-Prog/Suppl. Examination dated 18.08.2020 has intimated that in view of the situation arising due to the outbreak of COVID19 pandemic, the Supplementary SAS / RA/ I / CPD-I & II Examination (Corresponding to Main Examination 2019) could not be held till date. It has, therefore, been decided to complete the registration process and be prepared for conducting the examination at a short notice as soon as the situation is conducive.

In this regard it is intimated that the Registration portal will GoLive from 26th August 2020 to enable registration of eligible candidates who intend to appear in the upcoming examination. Only pre-registration of existing candidates (i.e. those who had registered for SAS / RA/ I / CPD-I & II Examination during (2000-2019) will be done in this phase i.e. the Supplementary SAS / RA/ I / CPD-I & CPD-II Examination would be conducted for the existing candidates i.e. the candidates who have appeared in SAS/RA/I/CPD-I & CPD-II Examinations held in November 2019 or earlier examinations but did not qualify the Examination.

All candidates fulfilling the eligibility criteria and intending to appear at the ensuing Supplementary SAS (Civil Accounts and Civil Audit for both Group-I/II) / Incentive / CPD-1 & II Examination in terms of Hdqrs Examination Circular No:7 of 2020 issued vide No. 159/09-Exam / Annual-Prog/Suppl. Examination dated 18.08.2020 may submit the filled in PRE-REGISTRATION FORM to Admn.I for generation of User ID and Password by the ERO. On receipt of the User IDs and Password, candidates may login in with the User IDs and Password received to their respective registered Mobile number and Email Ids and check Part-1 of the Registration Form which will be pre-filled. If the candidate agrees with the data filled in by the office, he/she should proceed further to fill up Part-II of the Registration Form and submit the same. Candidates are advised to check the particulars thoroughly and upload photo / signature before clicking the SUBMIT button.

Further, the candidates are instructed to complete and submit the Stage-II of the online registration process on or before the scheduled end of the online registration process.
